CITY MANAGER BRIEFINGS

PUBLIC SAFETY/CAMPUS SAFETY STUDY SESSION (MT. SAC)



A Study Session is scheduled for May 8, 2024 prior to the regular City Council meeting regarding Campus Safety and the Sheriff Contract as it relates to Mt. SAC. Topics of discussion will include:

- Memorandum of Understanding (MOU) - The current MOU between the Sheriff and Mt. SAC has expired and a new one will need to be created.
- Number of calls for Sheriff/Deputy service at the Mt. SAC campus.
- MT. SAC's daytime population and updated reporting district (RD) assigned to Mt. SAC.
- Time and resources Deputies/Sheriff personnel are spending dealing with Mt. SAC generated calls and its impact on response times and availability of Sheriff resources to other parts of the City and residents.
- A comparison of how other Community Colleges and adjacent Cal Poly Pomona handle public safety on their respective campuses.

PUBLIC SAFETY NOTES



There have been 402 Traffic Citations issued since March 1, with the most common violations cited being unsafe speed and fail to stop at a stop sign.

Notable Arrest: Last month, the Walnut Sheriff Station received a call of an assault with a deadly weapon in the parking lot of the Mt. SAC campus. A short time later, responding Deputies located the suspect vehicle, which was travelling on Brea Canyon Road, just outside the City limits.

Deputies initiated a high-risk traffic stop and the driver was positively identified by the victim and placed under arrest. Additionally, two firearms were recovered from inside the vehicle and taken off of our streets. Good work by our Sheriff Deputies.

CITY COMMISSIONS



The City Clerk’s office is now accepting applications from incumbents and new applicants for the following City commissions: Planning Commission, Parks & Recreation Commission, Senior Citizens Commission, and Youth Advisory Commission.

BUILDING BOOM CONTINUES



City-wide building permits have increased nearly 100% from last period to the current period, and increased 90% compared to numbers from last fiscal year. Overall, Building permits are currently at a 10% surplus over the Fiscal Year budget. Staff anticipates the continual increase in permit issuance, as large projects such as the Terraces progress resulting in increasing revenues that support Public Safety, Community Programs, and overall City Maintenance to ensure Walnut remains a desirable place to live and work.

FIRST EVER 3D PRINTED STRUCTURE IN WALNUT

An Accessory Dwelling Unit (ADU), has been approved and is under construction in the Snow Creek neighborhood. Through the use of a 3D printing robotic arm, the footprint of the ADU is mapped out and concrete is intricately poured to build the walls; no wood or nails are used in the process. The ADU is a detached, two (2) bedroom unit with a concrete tile roof. Builtech Construction Group, in conjunction with RIC Technology, anticipate a smooth, quick building process as the project continues.



TERRACES RESIDENTIAL/COMMERCIAL PROJECT (VALLEY BLVD)

Model homes for the Terraces development are open, by appointment only. There are four (4) sets of models of the small – lot, single family home product available to be toured. The Townhome models are currently under construction and expected to be completed this Summer. Meanwhile, construction on the 15,000 square – feet of commercial restaurant/retail space continues and the new traffic signal, located at the entrance of the development on Faure Avenue and Valley Boulevard, was energized on April 5th. Staff will provide more information on the new businesses that will be coming to the Community and the overall progress of the development in the upcoming months.
