Passport Services

"Walnut now offers photo services for Passport processing? No way!" Yes, we do! You will notice that the front desk of City Hall has received a slight "facelift." That is due to the new Passport Services / processes we have available for the community. Community members may now schedule an appointment, or come during the designated walk-in hours, and have their passport photo taken and printed, their DS-11 application reviewed and processed, and mailed for issuance with the Department of State. Walnut is now one of the few "one-stop shops" in the region—this new service and increased operating hours have been shared to the City's website and advertised on the City's Social Media pages.

The summer of 2025 was packed with enriching and engaging activities, drawing strong participation across a wide range of programs. Our community came together to make the most of the summer, with thousands of individuals taking part in recreational, educational, and social events.

2025 Summer Recap Statistics

- ·Contract classes led the way with 894 participants, offering skill-building and learning opportunities for all ages.
- · Aquatics programs also made a splash, attracting 464 individuals to swim lessons and adaptive lessons.
- · Youth and adult sports remained popular, with 258 people joining basketball programs, fostering teamwork and healthy competition.
- · Summer camps continued to be a staple for younger residents, bringing in 573 campers for fun, learning, and adventure.
- · Community members also embraced the opportunity to explore and connect beyond our city limits as 176 participated in excursions to new and exciting destinations.
- · Senior activities engaged 395 older adults, providing social interaction and wellness programs tailored to their needs.
- · The highlight of the summer, however, was our Special Events, including our Fourth of July event and our Music and Movies in the Park series which drew an impressive 12,500 attendees.

This summer's numbers showcase not only the variety of programs offered, but also the vibrant community spirit that made them such a success.







Community Development

New ADU Laws

On June 11, 2025, the City Council adopted Ordinance 25-04, incorporating new regulations for Accessory Dwelling Units (ADUs) as required by new State legislation. In the beginning of July, these new regulations became effective. A few of the key changes include:

- Maximum size allowed has been reduced from 1,200 s.f. to 1,000 s.f. or no more than 50% of existing SFR, whichever is less (in-line with State Requirements and that of neighboring Cities).
- Maximum number of ADUs allowed on a multi-family zoned property went from 2 units to 8 units or no more than the number of existing primary units, whichever is less.
- Height limit was reduced from 17 feet to no more than 16 feet.
- Additional procedures incorporated to legalize unpermitted ADUs and JADUs, consistent with State requirements.

Residents are encouraged to contact the Community Development Department with any questions or concerns.

Code Enforcement


In the last six (6) months, the Code Enforcement division has received over 340 new requests for inspection on violations throughout the City. Consequently, in the last six (6) months, Code Enforcement Staff has also facilitated compliance for over 300 on-going violations within the City, including the continued enforcement of three (3) public nuisance properties.

IDS Warehouse Project (Valley/Lemon)

Staff, the applicant, and the consultant are working on the final details of the project entitlements, including the draft of the Supplemental EIR (SEIR). It is anticipated that this project will go before the City Council before the end of the calendar year. Staff will continue to keep the Council apprised of the status once a meeting date is identified. The proposed four (4) buildings totaling over 400,000 square-feet of building area is located at the northeasterly corner of Valley Boulevard and Lemon Avenue totaling 20-acres.
