## **Recommendation:** That the City Council:

- 1. Appropriate \$248,221.77 of unallocated funds from ARPA Fund Reserves (08 Funds) to General Law Enforcement- Contractual Services to offset costs associated with the current fiscal year Sheriff's Department contract with Los Angeles County, thereby reducing the impact on the General Fund;
- 2. Authorize a 20% contingency allowance for the ARPA-funded LED Sports Field Lighting Project at Walnut Ranch Park, limited to allowable change orders, with no additional funding required; and
- 3. Direct staff to ensure all remaining ARPA funds are fully encumbered prior to the federal deadline of December 31, 2024.
