#### **PRESENTATIONS:**

• Introduction of New Program: "Pet of the Month Partnership Introduction with LA County Department of Animal Care and Control"

Council announced a new "Pet of the Month" partnership with the LA County Animal Care and Control that will take place at future Council meetings to help increase pet adoptions. Department rep Bradley Kim provided information on different services provided by the agency.

#### ORAL COMMUNICATIONS FOR THE CITY COUNCIL:

Rechelle Beams expressed her appreciation on behalf of St. Stephens Baptist Church for allowing them to host a concert in the park and mentioned it was well attended. She thanked Mayor Pro Tem Ching for his sponsorship of the stage and thanked the Community Services and Public Works staff for all their help.

William Harrison acknowledged the Sheriff's Department and the maintenance department for doing an outstanding job in the Creekside area; he would like to have the City Council revisit the term limits; he supports C/Tragarz and C/Freedman and MPT/Ching to do well in their elections; He would like to see more effort in encouraging residents to maintain their properties.

Muoy Li, Walnut Library manager, provided an update on the programs and events at the library she encourages residents to obtain their library card and participate and visit the website for all upcoming events.

Tom Kueshe, who volunteers with different animal shelters, shared that he is happy to see the City becoming more involved and hopes for more cities to become involved to help reduce the numbers in animal shelters.

There being no further person wishing to speak, the City Council closed oral communications.

## 2. Alamo Villages Project Located at 750 Nogales Street

- 1. **CEQA Exemption:** The seventy (70) residential units and related site improvements proposed for development at 750 Nogales Street qualify for a CEQA exemption pursuant to Public Resources Code Section 21083.3 and CEQA Guidelines Section 15183.
- 2. Alamo Villages Specific Plan (AVSP) and Zone Change 2024 02: A specific plan to implement the General Plan designation and facilitate the development of the subject property and zone change to implement the AVSP for the site.
- 3. **Development Agreement (DA):** A request for approval of a DA pursuant to Walnut Municipal Code (WMC) Chapter 6.112 (Development Agreement) and California Government Code Sections 65864 et seq. in connection with the development of seventy (70) residential units and related site improvements (APN: 8735 026 052).
- 4. **Tentative Tract Map (TTM) 83913:** A subdivision of 3.87-acres into seventy (70) townhomes and related site improvements such as site access and utility infrastructure.
- 5. **Site Plan Case/Architectural Review (SPC/AR) 2024-063**: Design review of the Alamo Villages Project for the proposed seventy (70) residential units and related site improvements.

  - c) Introduce by title only and waive further reading of Ordinance 24-05, approving (in substantial form) the Development Agreement (DA) for the Alamo Villages Project, and agendize for adoption at the regularly scheduled City Council meeting of September 11, 2024.

M/Freedman opened the public hearing at 7:23 p.m.

CDD/Vasquez provided a staff report and noted that the Planning Commission made recommendations and that the applicant has met the general plan and objective requirements.

Brent Little, applicant representative, provided information on the project and the assistance provided to the businesses in the center.

Dan and Sylvia Gerstner provided information on the project and thanked everyone in the community.

CC/De Dios announced there were 14 letters of support received from the applicant from current business owners on the property and five emails received expressing opposition or concerns regarding the project: Vijay Vakil, Wendy Toy, Andy Lui, Ritu Mahajan, and Alissa Rey.

Borris Teriaho, Kaylee May Law, Joseph Nawala, Steve Ortega, Andrew Castillo, William Harrison, Michael De la Rosa, Richard Magowin, Aziz Amiri, Joshua Lim, Craig Cruz, and Vijay Vakil expressed concerns or opposed the proposed project.

Love Ch Ch owners, Milan Bakini, and a Barbershop owner in the center requested assistance from the city for displaced businesses.

Sarah Klineburg, attorney for the Gershners, addressed CEQA, EIR, and general plan concerns discussed.

Jim Dixon Jr. expressed support for the project.

Greg Bonnet expressed concerns regarding CEQA due to the subdivision map approval.

Discussion took place between Council, staff, and consultant regarding the following: earthwork analysis, compensation to the current businesses in the center for termination, housing requirements from the State, details of the proposed project, development agreement fees, and CEQA details.

C/Wu expressed concerns regarding the soil analysis.

C/Cajulis asked that the notice of termination for businesses in the center be extended, to which Mr. Little stated they should be able to extend it by a couple of months.

Mr. Little addressed statements made during public comment.

C/Tragarz stated that she is empathetic for the businesses but acknowledges that the city must follow the rules and regulations from the State.

M/Freedman closed the public hearing at 9:45pm.
